Bike Walk Connecticut Meeting of the Board of Directors Wednesday, June 10, 2015 Teleconference

Present: Bill Young, Chris Skelly, Kevin Vicha, Ray Willis, Kelly Kennedy

- 1. The meeting was called to order at 6:30 by Bill Young.
- 2. The minutes of the May 13, 2015 meeting were reviewed and approved with one change: to append the results of the survey reviewed at the meeting. A motion was made to approve the minutes as amended. Motion seconded and passed.
- 3. In Scott's absence, Kelly summarized the previously distributed financial report. She noted that net income is much higher this year compared to last year at this time; we are positive where we were negative last year because of three revenue items.
 - The motion to accept the financials was made by Emily Chris seconded. Financials accepted into record.
- 4. ED Report Kelly reviewed the report on the legislative session, Bike to Work Day, the Summit and NACTO Workshop. Bike to Work Day was a nice event in Hartford but statewide participation was way down. Bike Safety legislation passed this session; Kelly doing end of session press release.
- 5. Discover West Hartford The event met its sponsorship goals but not its ridership goals. There were no mishaps which was a credit to the organization and the marshals. There was some feedback that the day of ride registration fee was on the high side. Reviews from participants were very good. Now the committee is working on the next ride in New Britain.
- 6. Multi-day ride: Kevin met with Susan Smith to discuss issues Matt had posed for the business plan. Susan put together a spreadsheet of six different rides she has been on, highlighting price points and length of rides etc. Kevin's goal is to make a recommendation at the July Board meeting of what BWCT's multi-day ride what it might look like; to present to Board a first pass at what we think might be right approach. Asked for volunteers. Will be on agenda as a primary item in July and Kevin will invite Susan Smith to attend.
- 7. Harvard Business School proposal HBS alumni group in CT has 2500 members. They have a group called community partners which does pro bono consulting for non-profit organizations. BWCT does not meet the criteria for pro bono consulting but there is an opportunity to do an organized brainstorming session

- 8. with the group. The Board discussed the benefits including possible outreach to new Board members and ideas for raising revenue. It was agreed that Kevin should pursue this opportunity, find out what information they would need and ask them for a sample case study so we can see what their deliverable would look like.
- 9. Board recruiting Colleen Kelly Alexander self-nominated. Nominating committee will review for recommendation to the Board.

New Bike Laws Effective July 1 Cyclists and Drivers Need to Know What's New









July 1, 2015 (Hartford, CT) -- Important changes to Connecticut's laws for cyclists take effect July 1, 2015. The Bicycle Safety bill, Senate Bill 502 and now Public Act 15-41, was passed in May with broad bipartisan support. The Governor signed the bill into law on June 1.

The new law eliminates the confusing--and often unsafe--rule requiring cyclists to ride as far to the right as practicable.

Instead, the law now requires cyclists to ride as close to the right side of the road **as is safe, as judged by the cyclist**. Bike Walk Connecticut specifically advocated for that language, which is modeled on a best practice from Colorado as identified by the League of American Bicyclists.

As of July 1, cyclists don't have to ride as close to the right side of the road when:

- 1. Overtaking or passing another vehicle proceeding in the same direction;
- 2. Preparing for a left turn at an intersection or into a private road or driveway;
- 3. Reasonably necessary to avoid conditions, including, but not limited to, fixed or moving objects, parked or moving vehicles, bicycles, pedestrians, animals, surface hazards or lanes that are too narrow for a bicycle and a motor vehicle to travel safely side by side within such lanes:
- 4. Approaching an intersection where right turns are permitted and there is a dedicated right turn lane, in which case a bicyclist may ride on the left-hand side of such dedicated lane, even if the bicyclist does not intend to turn right;
- 5. Riding on a roadway designated for one-way traffic, when the bicyclist may ride as near to the left-hand curb or edge of such roadway as judged safe by the bicyclist; or when
- Riding on parts of roadways separated for the exclusive use of bicycles, including, but not limited to, contra-flow bicycle lanes, left-handed cycle tracks or bicycle lanes on one-way streets and two-way cycle tracks or bicycle lanes.

The new law also allows two-way bicycle lanes, buffered bike lanes, and cycle tracks to be designed in Connecticut and allows drivers to cross the double yellow line to pass slower-moving cyclists and other road users when it's safe to do so.

Bike Shop and Bike Club Ambassadors

We first discussed the bike club/bike shop ambassador concept in March 2014. The purpose of having Bike Walk Connecticut directors function as ambassadors to CT bike clubs and bike shops is to:

- Re-engage bike shops across the state with Bike Walk Connecticut and build and maintain strong, long-lasting relationships with them;
- Raise awareness of Bike Walk Connecticut and our work among bike shop customers and bike club members;

Keep these handy:

✓ Brochures

✓ Bike Walk CT business cards

✓ Press Release on 2015 Bike Bill

✓ Business Membership flyer

- Build our base of individual members and donors;
- Acquire the financial and general support of bike shops and clubs, through business memberships, donations, or specific sponsorships;
- Ultimately, strengthen our statewide presence and revenue base.

How it Can Work

- 1. Each director would serve as an ambassador to at least 2 or 3 specific bike clubs and shops as close to their residence or workplace as possible.
- 2. Directors operate as the lead point of personal contact for all Bike Walk Connecticut matters specific to his or her bike shops and clubs.
- 3. Directors call and visit each of their bike shops or clubs once a month.
- 4. Initial visits will be to re-engage the bike shop or club or introduce them to Bike Walk Connecticut, for those that have had no previous relationship with us. Subsequent visits and calls will be to update the shops and clubs on our work, learn about their initiatives and interests, identify specific ways we can be of mutual assistance, and build our business and individual membership and donor base.
